Motion to approve May 20, 2015, meeting minutes was made by Hilary Terland. Seconded by Brian Rosenthal. Motion carried.

Pastor Larry Westfield, Regional Gift Planner, ELCA Foundation Lutheran Planned Giving of Wisconsin, was asked to attend our council meeting to give us information on trust funds. He is a resource for us from the Synod office.

Pastor Westfield shared the purpose of his role is to help grow funds that congregations have available for ministry, and to inform us what is available from the ELCA.

Pastor Westfield reviewed our By Laws. Our trust fund is an established endowment, which is to provide for an ongoing flow of money for ministry.

Memorials are given by the living and are often designated with an intended use to the church.

According to our By Laws our endowment is to be used for:

New Ministry

Responding to Stewardship opportunities

Money given to missions is to be designated as follows:

20% to national and local missions

20 % to world missions

40% missions as directed by council

Not to include Good Samaritan mission

Note-this is 20% short

Pastor Westfield stated we need to pay attention to Part III #2 in our by laws as it states American Lutheran Mission loan fund which no longer exists. It is now the Mission Investment of the ELCA and we should replace it with this information.

The Endowment's interest, growth dividends, capital gains, also known as net gain or total return, can be used.

We need to decide what is Memorial and what is Endowment (Trust) funds. How do we start?

What have we received in beguests?

Stock transfers or properties

Use this to formulate a dollar amount to flow into an Endowment (Trust) fund

Establish the dollar amount and start fresh

Possibly designate XX \$ for Memorial funds and XXX \$ for Endowment (Trust) funds

It is important to divide the funds and separate them Memorial vs Endowment (trust) as they have two very different purposes

Once established decide how to use Endowment (Trust) fund gain Recommends making a public recognition of the distributions

When deciding who to use to invest our funds in, decide what the mission in ministry is. If we use the Endowment Pool Trust Funds of the ELCA:

Eliminates Trust fund money manager and using banking affiliates and loosing connection to ministry.

No conflict of interest

Allows you know what you have available to distribute

Fees are 1/12 of 1% per month, approximately 1% per year.

\$25,000 needed to establish the account

Funds invested in reflects the values of the church. For example no company producing weapons.

Invests in opportunities to build communities

Uses the strength of Portico

Helps build the whole church vs Edward Jones shareholders

Quote Pastor Westfield shared, "It is more important to pass on our values, not our valuables."

Thanked Pastor Westfield for coming to share information with us on Trust funds. He is willing to come and help us or meet again as needed.

Financial Report:

No Financial report was given as Elizabeth was on a vacation. She did send an email to Council members stating that the deposits for May were \$15,163.65 and the balance of the General fund as of May 31, 2015 was \$20,402.24.
