Minutes from July meeting were reviewed with these corrections;

Financial report-#1 Adding "taken from Custodial Budget line to be put in custodial fund". #2 Income exceeded Expenses in June by \$1,701. To date, Income is trailing Expenses by \$10,441. General Offerings for June were \$626 more than for June 2017. To date, general Offerings are \$8,098 less than for the same time in 2017. #3 Financials for July-Expenses exceeded Income by \$10,648, largely because of the \$10,000 transfer for Custodial Labor to the Money Market account. To date, income is trailing Expenses by \$21,090. General Offerings for July were \$4,664 less than for the same month in 2017. To date General Offerings are \$12,762 less than for the same time in 2017.

Treasurers Report- We need to start work on 2019 Budgets. Committees to have Budgets in by Thursday Oct 11

The hiring of a new Financial Secretary update- contacted Drew Tax Service, they charge \$50 an hour. And there has been one applicant.

Tax assessment of Parsonage – Taxes were assessed at \$4,400, tax bill come in December. There will be a meeting with Dane County on September 26 to get parsonage and church separated, there is a \$486 fee for this.

Tuck Pointing update- Barb and Pastor Brenda met with property committee – quotes were received, it will be an 80 hour job at \$88 an hour and \$500 worth material needed. Motion was made by Sonja and seconded by Chris to get worked done.

New Business

Memorial Monies from Pastor Christensen donations were used to purchase banners and a Camp Scholarship has been created.

Sound System update – Two companies, ABI and IBS, have been to the church to give estimates on repairs for sound system. Worship Committee is reviewing proposals.

Youth Director funding- transfers needed to be done from Trust Fund Board
